Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. Are there services covered before you meet your deductible ?	Yes. Preventive care for In- Network Providers .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply.
